Avicena also Ibn Sina who was regarded as one of the most significant physicians, astronomers, thinkers and writers of the Islamic Golden Age, was born c.980 in Afshana, a village near Bukhara (in present day Uzbekistan).

At the age of ten years old, he learned and memorised the entire Quran. As a teenager, he was greatly troubled by the Metaphysics of Aristotle, which he couldn't understand until he read Al- Farabi's commentary on the work.

For the next year and half, he studied philosophy. At the age of sixteen, he turned to medicine. He didn't learn only medical theory but he also discovered new methods of treatment. He soon made great progress and became an excellent doctor and began to treat patients using approved remedies. He treated many patients without asking for payment.

His most famous works are The Book of Healing, a philosophical and scientific encyclopaedia, and The Canon of Medicine, a medical encyclopaedia which became a standard medical text at many medieval universities and remained in use as late as 1650. In 1973, Avicenna's Canon of Medicine was reprinted in New York. Ibn Sina died on June 21st 1037.
