Bribery, is a form of pecuniary corruption constitutes a crime and is defined as the offering receiving, or soliciting of any item of value to influence the actions of an official or other person in discharge of a public or legal duty. The bribe is the gift bestowed to influence the recipient conduct. **It** may be any money, good, right in action, property privilege, advantage, or merely a promise or undertaking to induce or influence the action, vote, or influence of a person in an official public capacity.

The offence may be divided into two great classes: **the one** where a person invested with power is induced by payment to use it unjustly; the other, where power obtained by purchasing the suffrage of those who can impart it. Likewise, the briber might hold a powerful role and control the transaction; a bribe may be effectively extracted from the person giving paying it, although this is better known as extortion.

The forms that bribery takes are numerous. For example, a motorist might bribe a police officer to issue a ticket for speeding, a citizen seeking paperwork or utility line connections might bribe a functionary for faster service. Bribery may also take the form of a secret commission, a profit made by an agent, in the course of his employment, without the knowledge of **his** principal. Bribers and recipients of bribery are likewise numerous although bribers have one common denominator and that is the financial ability to bribe.
