When we think of ancient civilisations of the Nile, most of us immediately picture the grand pyramids and temples of Egypt. However, another powerful kingdom thrived along the banks of the great ancient Egyptian Nile River. This was the kingdom of Kerma, an ancient African civilisation, which irished from around 2500 BC to 1500 BC.

Kerma was located in what is now modern-day Sudan. Its capital was a sprawling city with a complex urban design, including a royal palace, temples, public buildings, and residential neighbourhoods Unlike ancient cities on the Nile which were built of stone, many of Kerma's buildings were mud-brick and timber. This has made the preservation of archaeological sites more challenging.

Like many civilisations on the Nile River, Kerma's economy was based on agriculture. It also had

a solid cattle-raising tradition and trade in luxury goods such as gold, every and exotic woods.

Although the ancient kingdom of Kerma declined, its legacy continued to influence later African civilisations for centuries. The kingdom's distinctive cultural and artistic traditions and strategic location along the ancient Nile Valley influenced the region's history. It also played a vital role in the Pan-African movement fof the 20th century. It sought to reclaim and celebrate the cultural heritage of Africa. Most importantly, Kerma's legacy as a powerful and in dependent diricion kingdom inspired later generations to resist colonialism and assert their cultural identities.

Part One: Reading A/ Comprehension (14 points) (07 points)

Read the text carefully to do the activities.

Nepotism takes place when someone with power ignores more qualified candidates to hire or to advance family members. It also occurs when employers treat the favoured employees better than other workers, like: ignoring their habitual lateness at work, promoting them over the more deserving ones, and not addressing their poor work performance.

Nepotism can hurt employers, employees, and the entire company. Hiring unqualified family members may create an unhealthy work environment. It can lead to dissatisfied employees, and opens employers up to accusations of unethical conducts. Imagine a qualified employee who performs their job well and gets along with co-workers. Now imagine that employee's reaction when an expected promotion goes to the manager's niece who always comes late, never works seriously and treats colleagues with disrespect.

Technically, nepotism is always wrong, but "nepotism" and "hiring family members" are not synonymous. Nepotism shows favouritism because of family connections. It is wrong because it is based on choosing someone for reasons other than merit. However, hiring family members is not always wrong, as long as no conflict of interest exists.

Preventing nepotism is the best way to handle it. There should be an official code of ethics that addresses nepotism. We can add whistle-blower protection for employees to report nepotism and establish clear hiring processes.
